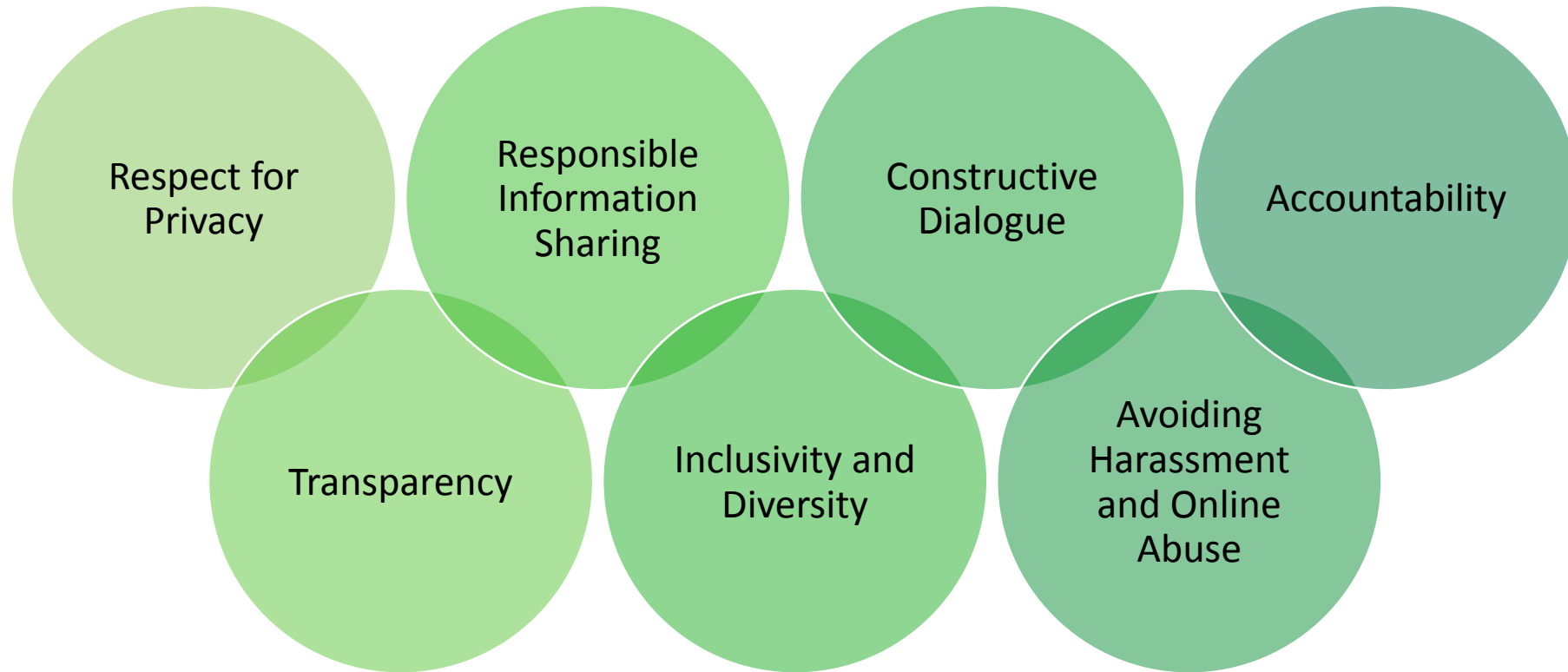


# Ethical considerations in digital activism

- Respect the privacy of individuals involved in your campaign
- Be mindful of collecting and handling personal data
- Ensure compliance with relevant data protection regulations
- Recognize and respect diverse cultural perspectives
- Protect yourself and your supporters from online harassment
- Make your content accessible to all, including people with disabilities and limited internet access
- Verify information and sources before sharing them to prevent the spread of misinformation
- Take responsibility for the consequences of your activism
